Research grant agreement between Sri Lanka College of Sexual Health and HIV Medicine (the "Grant Provider") and grant recipient (the "Grantee").

This Research Grant Agreement ("Agreement") is entered into on (the "Effective Date") by

WHEREAS the Grant Provider desires to provide the Grantee with funding for the purposes of supporting
research on the Project Titled
, and the Grantee is willing to
accept such funding subject to the terms and conditions set forth herein.
NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties
agree as follows:
Funding: The Grant Provider agrees to provide the Grantee with a grant in the amount of
Rs (the "Grant Amount") to support research on the Project Title. The Grant Amount will
be paid to the Grantee in four installments as follows:

- a. Twenty-five percent after accepting the research proposal and signing the contract.
- b. Twenty-five percent after submitting an interim report with data tables.
- c. Twenty-five percent after submitting and accepting the final report.
- d. Twenty-five percent after publication or presentation in an acceptable forum.

Use of Funds: The Grantee shall use the Grant Amount solely for the purposes of conducting the research on the Project Title described in the grant proposal submitted to the Grant Provider (the "Proposal"). The Grantee shall provide the Grant Provider with periodic reports (once in 6 months and a final report after completing the research) detailing the progress of the research, including how the Grant Amount is being utilized.

Term: This Agreement shall commence on the Effective Date and shall continue until the completion of the research project (within one year unless approved for an extension of time) or until the termination of this Agreement by either party, whichever occurs first.

Intellectual Property: Any intellectual property rights arising from the research conducted under this Agreement shall be the sole property of the Grantee.

Publications and Acknowledgment: The Grantee agrees to acknowledge the Grant Provider's support in all publications resulting from the research funded under this Agreement. The Grantee further agrees to provide the Grant Provider with copies of all such publications.

Confidentiality: The Grantee agrees to keep confidential any information received from the Grant Provider in connection with this Agreement and not to disclose such information to any third party without the prior written consent of the Grant Provider.

Termination: Either party may terminate this Agreement upon written notice to the other party if the other party is in material breach of this Agreement and fails to cure such breach within [Number] days after receipt of written notice of such breach.

Entire Agreement: This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral, relating to the subject matter hereof.
